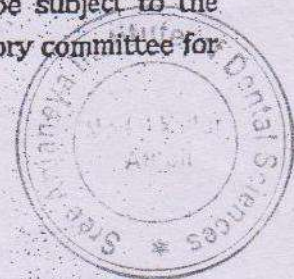

**ORDER**

1. The Kerala University of Health Sciences has granted provisional affiliation vide order read (2) above for starting of Sree Anjaneya Institute of Dental Sciences with annual intake of 50 seats. Now, the Chairman, Sree Anjaneya Medical Trust has submitted an application read (3) above requesting for provisional affiliation with annual intake of 100 seats.
2. The University has granted consent of affiliation for starting BDS course at Sree Anjaneya Institute of Dental Sciences with annual intake of 100 seats and as per paper read (3) above, the Ministry of Health & Family Welfare, New Delhi has granted letter of intent to start BDS course at Sree Anjaneya Institute of Dental Sciences, Modakkallur with annual intake of 100 seats for the academic year 2013-14.
3. The College has remitted provisional affiliation fee of Rs. 8,00,000/- and refundable deposit of Rs. 15,00,000/- fixed by the University for the academic year 2012-13 on the basis of the interim stay on the writ petition cited 5<sup>th</sup> above and has to pay balance amount of Rs. 2,00,000/- (Rupees Two lakh only) as provisional affiliation fee and Rs. 5,00,000/- (Rupees Five lakh only) as refundable deposit subject to disposal of writ petition.
4. Sanction has therefore been accorded by the Vice Chancellor, in exercising his powers under Section 12(7) of Kerala University of Health

Sciences Act 2010, to grant conditional provisional affiliation to Sree Anjaneya Institute of Dental sciences for starting BDS course with an annual intake of 100 seats for the academic year 2013-14 subject to conditions mentioned below: -

- a. Selection, Admission and collection of fees shall be made only on the basis of the rules and regulations of the University and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- b. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- c. Collection of Annual administration fee from the students under any circumstances is not permitted and annual administration fee should be remitted within 10 days after the closure of admission.
- d. Affiliation granted is strictly provisional and only for the academic year 2013-14. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- d. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- e. If the college fails to remit the balance fee on disposal of the writ petition the conditional affiliation granted shall cease automatically.
- f. Admissions made in the sanctioned intake shall be subject to the approval of the Govt. of Kerala/Admission Supervisory committee for professional colleges.



g. The College should collect fees from the students to be remitted to this University as follows: -
