ORDER

As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2015-16 from colleges for courses affiliated to this University. The Principal, Sree Anjaneya Institute Of Dental Sciences, Modakkallur-MD023 has submitted application for the continuation of provisional affiliation for the year 2015-16 vide paper read (2) above.

On verification of the applications it is found eligible to grant Continuation of Provisional Affiliation to Sree Anjaneya Institute Of Dental Sciences, Modakkallur-MD023 for the academic year 2015-16 as they have remitted necessary fee, acquired satisfactory inspection report of KUHS and have obtained permission from the Central council for the academic year 2015-16.

Sanction, has therefore been accorded by the Vice-Chancellor by exercising the powers conferred under chapter 3, section 12(7) of Kerala University of Health Sciences Act, 2010 to grant continuation of provisional affiliation to Sree Anjaneya Institute Of Dental Sciences, Modakkallur-MD023 for conducting BDS course with an annual intake of 100 students (One hundred only) during the academic year 2015-16 subject to ratification by the Governing Council as per the conditions detailed below:-

1. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
2. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.

3. Affiliation granted is strictly provisional and only for the academic year 2015-16.
4. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
5. The College should remit annual administration fee fixed for UG course for the academic year 2015-16.
6. Admission to the next academic year shall be made only after obtaining prior permission from the University.
