### ORDER

As per paper read (1) above, applications were invited for the grant of continuation of provisional affiliation for the academic year 2019-20 from colleges for courses affiliated to the University. The Principals of Sree Anjaneya Institute of Dental Sciences, Modakkallur, Mar Baselios Dental College, Ernakulam and Noorul Islam College of Dental Sciences, Thiruvananthapuram have submitted applications, read as (2) above with requisite fee.

2) The 23<sup>rd</sup> meeting of the Governing Council vide paper read (3) above, decided to conduct inspections for granting continuation of Provisional Affiliation, in every two years in all colleges except those colleges where first batch of UG/PG courses/Super Specialty has not passed out. Since the first batch has been passed out and no deficiencies were noted during the previous year, inspections for the grant of Continuation of Provisional Affiliation for the Academic year 2019-20 were not conducted at Sree Anjaneya Institute of Dental Sciences, Modakkallur, Mar Baselios Dental College, Ernakulam and at Noorul Islam College of Dental Sciences, Thiruvananthapuram. The Colleges vide paper read (4) above, have submitted recognition orders from Ministry of Health & Family Welfare Department Government of India.

3) The 51<sup>st</sup> meeting of the Governing Council held on 01/03/2019 vide paper read (5) above have decided to grant Continuation of Provisional Affiliation to UG /PG courses in the above three Colleges for the academic year 2019-20 .

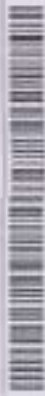

- i. Selection, admission and collection of fees shall be made only on the basis of the rules and regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be canceled.
- ii. In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- iii. Affiliation granted is strictly provisional and only for the academic year 2019-20. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- iv. The College should remit annual administration fee fixed for UG/PG course for the academic year 2019-20.
- v. Admission to the next academic year shall be made only after obtaining prior permission from the University.

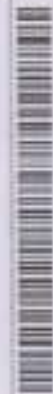
